# Seeking input from the EDC:

- Recommendations for community members/businesses to consult
  - o For example food producers who may use kitchen
- Recommendations for who I should approach for letters of support

**Grant Questions I need input on** (from entire EDC or a potential working group, as deemed appropriate at the Sept 11th EDC meeting). *I've provided my guestimate answers below:* 

- What are the key economic sectors or drivers within the community?
  - Tourism, Retail, Services, Community Forest, Real-Estate, Remote Work, Agriculture, Food service . . .
- What community need are we trying to address?
  - o Business incubation, job creation, access to products/services . . .
- How many direct jobs do we predict from the building of a shared-use commercial kitchen? - Full-time, part-time, casual, seasonal
  - Describe these jobs: One manager position to oversee the use and bookings of the kitchen. We forsee the development of at least 2 food processors/producers in Kaslo, resulting in 2 full time and 6 part time and 6 casual positions
- Who will own completed infrastructure?
- How dependent is your community on the forestry sector?
  - o On a scale of 5 Not at all to Very dependent
  - Describe Forest Sector's Role in your community
  - Has the forestry sector in your community been impacted, or is it projected to be impacted, by closures or curtailments within the sector or recent regulatory changes such as old growth deferrals and pauses in BC Timber Sales?
